

Licencing Information

OPTION 1 – INTRANET LICENCE

The intranet licence allows company employees to access the training via computer or other devices 24/7. (In the same way employees access shared work files). What's more, it has your company logo embedded giving you ownership. The intranet licence opens up a myriad of possibilities, it allows for self-based training. This can be extremely beneficial in the long run helping certain constraints. A licence Quote is based on the number of users. Please find attached further information. Once a licence agreement is completed we will require your corporate logo which will be added to the opening screen of the program. We will then supply digital media (containing enriched files) of the program so that your IT department can load these onto your intranet server. Adding your logo to the program personalises it for your employees- and also deters use by any other companies not licenced to use the program.

Cost: We offer a licencing agreement authorising the use of the program on a company's intranet. The licence fee is based on the number of employees. The cost will also be determined by the terms of the licence period e.g. one, two or three years. It affords training employees at an economical cost per person.

Benefits:

- Saves additional time and money involved in setting up group training sessions for large numbers of people, as one can train employees at minimal cost per person.
- Employees can download associated handouts.

This gives a company access to training via individual computers in the same way shared work files are accessed.

The advantage of an intranet licence is that it allows for self-based training which can be beneficial in working around constraints such as shift work.

Steps to setting up intranet learning from a company intranet:

1. A licence agreement is completed and you provide us your corporate logo which will be used to customise the program. Adding your logo to the program personalises it for your employees, and also deters any use by other companies not licenced to use the program. We then supply files of the program and training support material.
2. Your IT department loads the files onto your intranet server.
3. Company personnel can log in and view the video content simply by connecting to the company's intranet.

OPTION 2 – CORPORATE LICENCE

A Corporate Licence will provide unlimited access to the training programs for all employees 24/7 in perpetuity. The content may be used in various formats and applications best suited to your safety training programs and objectives via DVD, intranet and/or secure protected internet. The content becomes available (naturally the copyright remains with the producers) to use, in perpetuity. It is also available for your corporate branding. As a further benefit in the Corporate Video Licence, language versions of the programs, if available, would also be included at no further cost.

A Licence Quote is provided based on the number of employees. Once a licence agreement is completed we will supply the following training materials:

- Electronic video files customised with your corporate logo/safety message/branding. The licence precludes the content being used by any companies other than your company. To that effect all digital files must bear the company name and logo and a copyright warning in that regard.
- All relevant training support material.
- Copyright permission to replicate all the training material (video, PPT, assessment, etc.) on CD or host on your intranet for the all employees within your company. This also includes permission to produce additional language versions of the film and support material through reputable production facilities and with the proviso that a master disc for each language or support material is sent to us for final approval.
- Lifetime licensing- no annual renewals.

With a corporate licence, you have permanent access to using the training programs within your organisation at a fixed price that you can disseminate across the organisation.
